TO: GENFLEX VALUED CUSTOMERS IN CALIFORNIA

SUBJECT: GENFLEX ROOFING PRODUCT EXCHANGE

TO: DISTRIBUTORS

It has come to our attention that certain GenFlex brand roofing adhesives, sealants, and primers that exceed certain VOC limits have been shipped into the state of California, and in some instances may be available for sale in air quality management districts where they cannot be used. Even though these products are properly labeled, because they exceed some of the California air quality management districts' VOC limits and thus cannot be used in those districts, we have decided to exchange them for products meeting those limits. The products with VOCs in excess of applicable limits in some California air quality management districts are the following:

1. EPDM Bonding Adhesive, W59 001 0152
2. EPDM Bonding Adhesive LVOC, W59 001 0173
3. TPO Bonding Adhesive LVOC, W59 003 0098
4. TPO Bonding Adhesive, W59 001 0076
5. All Purpose Bonding Adhesive, W59 001 0158, W59 001 0157
6. GenSplice Adhesive, W59 001 0148
7. TPO Edge Sealant, W59 003 0022, W59 003 0211, W59 003 0255
8. Clear Primer, W59 003 0025, W59 003 0088, W59 003 0089
9. GenPrime, W59 001 0143, W59 001 0141

10. Cleaner W59 001 0093 – At this time, GenFlex does not produce an LVOC substitute for Cleaner W59 001 0093. Although Acetone is a like-substitute for Cleaner W59 001 0093, it is available by others. GenFlex will issue credits for Cleaner W59 001 0093.

To assist in this matter, GenFlex is implementing an exchange program. Please note that this program will be implemented immediately. GenFlex will discontinue shipping the above ten products into California. GenFlex Distributors will be contacted by a designated GenFlex representative within the next 5-7 business days to determine the quantity of products you may need exchanged with products that comply with the VOC limits.



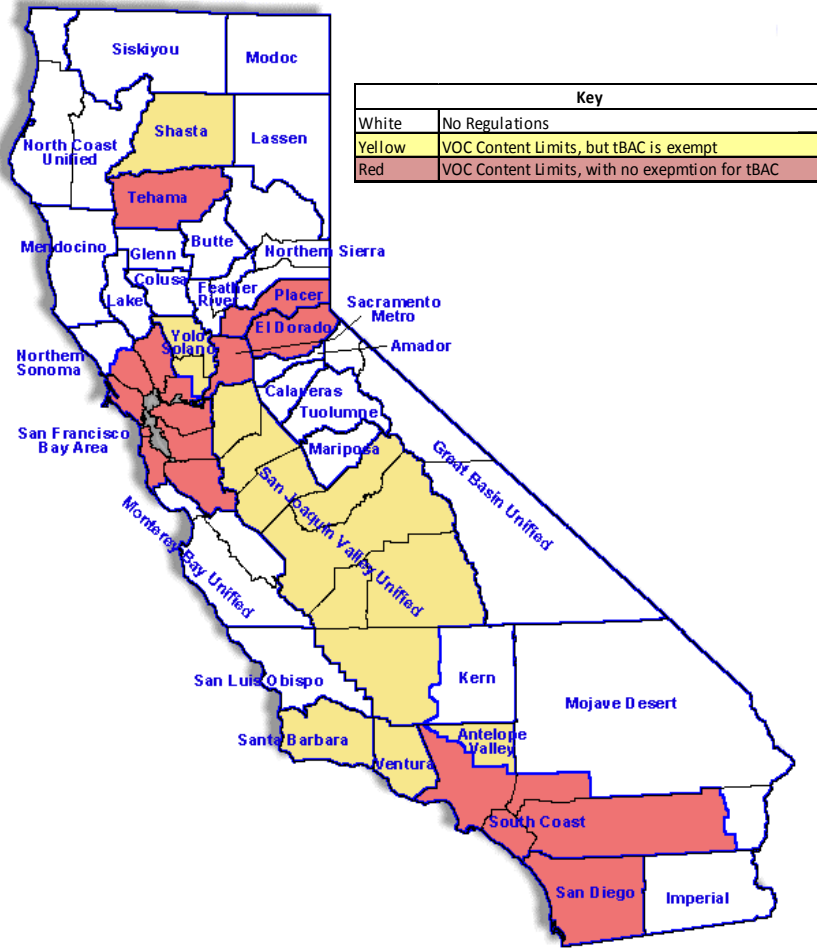
