## **RE: OZONE TRANSPORT COMMISSION (OTC) Model Rule for Adhesives and Sealants**

As part of the effort to achieve federally mandated standards in the Northeast and Mid-Atlantic states, the Ozone Transport Commission (OTC) developed Model Rules for adhesives and sealants. These Model Rules regulate the Volatile Organic Compound (VOC) content found in adhesives and sealants used in the roofing industry. Specific language within state-by-state regulations may vary slightly, but the OTC Model Rule generally requires that adhesives, sealants and primers used in those states contain a maximum of 250 g/L of VOCs.
