**RE: OZONE TRANSPORT COMMISSION (OTC) MODEL RULE FOR ADHESIVES AND SEALANTS -
SELL THROUGH PERIOD CLARIFICATIONS FOR PENNSYLVANIA AND WASHINGTON, DC**

On September 8, 2011, Genflex Roofing Systems published a Marketing Bulletin informing our customers that the Ozone Transport Commission (OTC) regulations take full effect on January 1st, 2012. This bulletin provided a summary of the 2011 and 2012 effective dates for states that had implemented versions of the OTC Model Rule. It also included a list of Genflex adhesives and sealants that meet the OTC Model Rule and state requirements. Since this bulletin was issued, Genflex would like to clarify certain provisions of the regulations implemented by Pennsylvania and the District of Columbia.

The following clarifications define both the "sell through" and "use through" dates of applicable products in the aforementioned state/district. The variances contained therein allow for limited sale and/or use of products manufactured prior to the OTC effective date (January 1, 2012) to be sold and/or used after this date.

	"Sell Through" and "Use Through" Period Clarifications
State of Pennsylvania	<ul style="list-style-type: none"> Limited sell-through and use of existing products on or after the effective date If a product is manufactured prior to January 1, 2012, it may be sold, supplied, or offered for sale on or after January 1, 2012 ONLY IF the product displays on the container or package the date on which the product was manufactured, or the code indicating the date has been approved and registered.
District of Columbia	<ul style="list-style-type: none"> Limited sell-through and use of existing products on or after the effective date. No person shall use or apply any adhesive, sealant, adhesive primer, or sealant primer <u>manufactured on and after January 1, 2012</u>, within the District of Columbia in excess of the applicable VOC content limits specified in the table of standards except as provided in subsection 744.5 and 745.

Please be aware of the guidelines for use as the effective date for these new regulations nears. It is imperative that you make sure that you are aware of these Model Rules, state specific rules and exceptions, and the corresponding effective dates. Only compliant products should be sold, offered for sale, and/or used as described within your specific state's regulatory requirements. For an up-to-date and accurate list of the regulations and their implementation schedule, please refer to your state's specific regulations. Genflex will communicate to you any changes to the date code on its products in the future. Furthermore, the EPDM Roofing Association also provides state specific OTC information at www.epdmroofs.org.
